**TECHNICAL REQUIREMENTS:**

SEWER - Under no circumstances shall any new fixture be installed in a building lower than the front curb elevation or street centerline elevation, whichever is higher, unless special precautions are incorporated into the new fixture installation to prevent surcharging of the new fixture from the sanitary sewer main from high flow or blockage.

Lateral from the house to the main shall either be cast iron or PVC pipe. The connection to the main shall be through an approved wye or saddle. An MMUA Representative shall be present at the time of the tapping into the MMUA main.

A vertical inspection riser shall be installed in accordance with the attached Detail Sheet.

WATER - Lateral from house to main shall be 1" 'K' copper with a curb stop and box one foot inside the curb. Valves shall be installed on each side of the Meter Yoke. Yoke may be picked up at the MMUA office and shall be installed by the plumber. MMUA shall install a meter with a remote readout.
