All bids must be submitted to the Authority Business Office not later than the time advertised. Each bid must be enclosed in a sealed envelope and the provisions as set forth in the "Advertisement for Sealed Bids" be followed.

"BIDDERS ARE REQUIRED TO COMPLY WITH THE REQUIREMENTS OF N.J.S.A.10:5-31. and N.J.A.C. 17:27 et seq. (Affirmative Action.) The bidder is also further notified that he must comply with P.L 2004 c. 57 and submit proof of a New Jersey Business Registration Certificate and submit proof of business registration for any named subcontractors in accordance with the act.

The Authority reserves the right to reject any or all bids if deemed to be in the best interest of the Authority to do so. The Monroe Municipal Utilities Authority also reserves the right to hold all bids up to sixty (60) days before rejecting or awarding any bid.

ULTRA LOW SULFUR DIESEL FUEL

DETAILED SPECIFICATIONS:

A. The diesel fuel must be of the grade now regularly manufactured and suitable for use in compression ignition internal combustion engines and equal in every respect to the type and grade being delivered to the Monroe MUA by the contractor under a recognized trade name; no so-called "competitive grade" will be accepted.

B. All grades of diesel fuel contained in this proposal shall be uniform first quality low-sulfur type which shall conform in all respects to the requirements as set forth in the United States Department of Commercial Standards CS-12-48 for domestic and industrial fuel oils, and chapter X of the New Jersey Air Pollution Control Code on "Control and Prohibition of Air Pollution from sulfur dioxide caused by the combustion of fuel" as per specifications listed below and herein made a part of this proposal, and as adopted by the New Jersey State Department of Health.

ULTRA LOW SULFUR DIESEL FUEL OIL

General: the diesel fuel oil shall be a clear hydrocarbon oil, free from suspended water and free from sediment or suspended foreign matter.

Physical and Chemical: the diesel fuel oil shall conform to the limiting requirements set forth in Table 1 when tested as specified herein.

During the performance of this contract, the contractor agrees as follows:

APPENDIX A
AMERICANS WITH DISABILITIES ACT OF 1990
