**RESOLUTION OF THE MONROE MUNICIPAL UTILITIES AUTHORITY TO
AWARD A NON-FAIR AND OPEN CONTRACT TO ACE PLUMBING HEATING
& ELECTRICAL, INC. FOR THE PURCHASE OF ELECTRICAL AND
PLUMBING SUPPLIES IN AN AMOUNT NOT TO EXCEED \$50,000.00 FOR
THE PERIOD COVERING JULY 16, 2026, THROUGH JULY 16, 2027**

WHEREAS, the Monroe Municipal Utilities Authority a duly constituted public body in the County of Gloucester, State of New Jersey, has a need to acquire electrical supplies as a Non-Fair and Open contract pursuant to N.J.S.A. 19:44A-20, et. seq.; and

WHEREAS, Ace Plumbing Heating & Electrical, Inc., has completed and submitted a Business Entity Disclosure Certification which certifies that Ace Plumbing Heating & Electrical has not made any reportable contributions to a political or candidate committee in the Township of Monroe, Gloucester County, in the previous one year, and that the contract will prohibit Ace Plumbing Heating & Electrical, Inc. from making any reportable contributions through the term of the contract; and

WHEREAS, the Certifying Financial Officer has certified that the funds as stated in this resolution are available to the Authority.

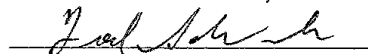

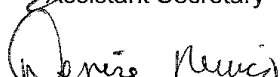
NOW, THEREFORE BE IT RESOLVED on July 15, 2026, upon proper motion and vote at a public meeting by the Monroe Municipal Utilities Authority, County of Gloucester, State of New Jersey as follows:

1. The Authority's Executive Director is authorized to enter a contract with Ace Plumbing Heating & Electrical for the purchase of electrical and plumbing supplies which contract shall be in a form approved by the Authority Solicitor ("Agreement".) The total payment for supplies under the agreement shall not exceed \$50,000.00.
2. The agreement is contingent on the Authority's Certifying Financial Officer's certification that there are sufficient funds to pay for the supplies.
3. The Authority shall publish a brief notice stating the nature, duration, service, and amount of the agreement, and that the Resolution and agreement are on file and available for public inspection in the office of the Authority.
4. The Authority's Officers and Professionals are authorized to take the actions necessary to achieve the purpose of this Resolution.
